# **Resolution No. 1: Presentation of Trustees Report**

19.05 Calum presented the main points, explaining that because of the Covid pandemic, that it was a little more slow than usual over the past year.

Calum covered our main action groups:

- Events, Marketing Media and Signage
- Roman Gardens
- Spirit of Place
- Gardening and Environment

The year in review main points:

- Signposting to residents with help from the councillors, re help and guidance in the Covid Pandemic.
- Roman Gardens planning wins, including £8k funding lighting plan for the North Gate and resurfacing the main pathway. Lang O'Rourke have offered in-kind labour for completing East-West pathway – expected to be completed this year.
- Spirit of Place project has moved on to run a pilot scheme to look at graffiti issues around Castlefield
  and bring together stakeholders as well as working with the council to combat.
- Calum thanked Gary Rumens for his hard work with Castlfield Litter Pickers over the lockdowns. This has still continued and has been really successful. As well as litter picking, there has been a push this year for signage around to remind visitors to the area not to drop litter.
- After a slower year, trustees picked up work using virtual means and we are looking for feedback on this
  virtual event to plan better the needs of the members.

Calum ended by thanking the Trustees for the work they had done this year.

# Resolution No 1: Presentation of Treasurers Report for year ended April 30th 2020.

19.10 As a continuation to the above, Giles Grover – Forum Treasurer, spoke about the accounts for the year ending April 30<sup>th</sup> 2020. Giles noted the information in the Treasurer's Report, available in the AGM pack as above.

We became a Registered Charitable Organisation on 9<sup>th</sup> April 2019 and accounts end 30<sup>th</sup> April 2020. Our current income falls between £5k-10k so we are able to account as such as covered in our pack.

Giles explained that the Accounts had been formally independently examined by Dan Coles FCCA and a copy was included in the AGM Pack also.

Giles checked if here were any questions regarding the financial report circulated – there were none.

Carol thanked Giles for his work over the year keeping the accounts in order.

Post meeting comments: During the voting process for the trustee election process, members were asked to Vote on: 'Resolution No. 1: To receive the report of the Company Directors (Trustees) and the company's Reviewed Financial statements'. The Resolution was passed by majority vote as follows

36 votes For 0 Votes Against 2 Votes Abstained

There were four proxy votes.

19.15 James Bowers – Forum Secretary, thanked all those in attendance as it made the meeting quorate as part of our charity requirements.

James explained that our AGM voting was different this year, and was done by online poll rather than voting in the room as per usual years. The voting was done in the week before the AGM, and the deadline for online (and postal) was by midday on the day of the AGM. This allowed for the results to be displayed for each resolution.

James explained that as part of our constitutional requirements,  $1/3^{rd}$  of trustees must retire at each AGM. With 9 trustees, 3 were asked to resign by rotation. These were:

- Debbie Hubbard
- Giles Grover

James explained that all three had re stood for election and the biographies for them were available in the voting packs for the AGM.

#### Resolution No. 2: Outcome of Election Process for Trustees.

James continued that because of completed voting, we could show the results as follows:
